A new era. Centennial Park was designed to support sport fishers: boat launch, trailer storage, and RV camping. Over time it added expanded moorage, a playground and the Smiley Rink, information centre with showers, and took on responsibility of westside outhouses. Now the park accommodates a community garden, the Memorial Pavilion with the Memorial Tree and benches and a fire-pit: that support music, public pig roasts and the like. Mostly, the park is self-supported with a ~\$8K ACRD grant. Lisa Herbig, a part-time manager works with commissionaires Eileen Scott and Roger Demontigny, who 24/7, with an army of volunteers drive the park forward. Centennial Park has maxed out in accommodating the sport-fishing public. This market focuses on the July-September season. A typical user has an RV, a trailered-boat, and a spouse. To expand the users, the Park had Heather Alexander design a website (www.bamfieldparks.com), promoting the Bamfield camping experience. Reasonably, the park should cater to the camping public, year-around, but concentrating on the May-October window. Camping and RV'ing are not compatible (see photo). Thus, a vehicle-free camp site is required. This and other issues need to be addressed. Three new commissionaires are sought to address this and other issues. Two positions will be decided at the October Affairs meeting. L. Druehl

Some transfer station challenges: not sorting recyclings, leaving un-cyclable things like tires leave one and they procreate", not following directions (when the "No garbage, please" sign was up, people left garbage out, costing one bear its life). "Right now, everything is fine, as much needed changes to the transfer station have made a big difference." She loves interacting with depot users, local and visitors, and wants users to have an enjoyable experience, "Folks have called me the town ambassador." Suzanne and

her partner, **Patrick McNamara**, have a sweet bungalow on Binnacle Road. Suzanne thanks all the folks who help at the depot, especially Patrick. And we thank you, Suzanne. *Louis Druehl*

Summer is over. The September Community Affairs meeting was attended by 28. Kristin Russell, Secretary, read correspondence from Mike Surrell, owner, Lady Rose Marine Services (see www.bamfielder.ca for full letter). They propose to provide car-ferry service to Bamfield with the MV Alberni Legacy. The Bamfield terminal will be the old Ostrom ice plant (now HFN property). Discussion focused on the positive aspect of this development but, with concern, this project, which could largely impact Bamfield was only now being disclosed to the village. It was agreed, Affairs write Mike Surrell complimenting him on this initiative and inviting him to discuss it further at October Affairs meeting. Our ACRD rep. Keith Wyton noted: There will be an ACRD meeting on 12 October, to review non-B&B rentals in Bamfield. He reviewed progress on parking issues and the water treatment system (delayed as bids exceeded budget). The Bamfield Parks Commission needs 3 new members (1 to be selected by ACRD rep. and 2 by vote at the October Community Affairs: nominations to Keith or at the next meeting). Bernadette Wyton reviewed the Barkley Sound Planning Strategy, promoting its employment in evaluating maior Barkley Sound projects. Kristin Russell noted 21 students this year, with classes K to 8. Check October events for buddy reading, community lunch and other. Janessa Dornstauder noted a successful summer program and Fungus workshop (~100 participants), and forthcoming Authors, Oysters and Ale. Stefan Ochman reported on the Bamfield Road Safety and Anacla & Bamfield Community Forest committees: progress is happening. Robert Dennis, Sr. thanked Bamfielders for their support of HFN enterprises. He suggested greater cooperation with Bamfield business. The HFN subdivision is underway. By means of clarification, Robert noted the HFN had approved the consultation process evaluating the transportation hub. John Mass thanked the HFN for the Anacla-Bamfield trail. L. Druehl

A long struggle happily completed. Huu-ay -aht First Nations is pleased to hear Canada will accept the Specific Claims Tribunal decision awarding the Nation \$13.8 million in compensation for breaches of duty. Huu-ayaht filed a claim with the Tribunal in 2011 about logging that took place between 1948 and 1969. In 2014, the Tribunal found that Canada had breached its obligations numerous times. In December 2016, the Specific Claims Tribunal awarded \$13.8 million in compensation to HFN. In January 2017, the Nation was notified that the Canadian Government would appeal. On September 5, 2017, Huu-ay-aht received word that Canada did not plan to further prolong the decision by going through a judicial review process. "We are happy that Canada is going to honour its commitment to reconciliation by accepting this ruling," explained Robert Dennis, Sr. (www.bamfielder.ca for full release).
